ORDER

Smt. V. Girija, Sewing Teacher, Government High School, Ezhoor, Malappuram had availed Leave Without Allowance for undergoing B.Ed. Course from 11/06/2001 to 30/03/2002. As per Government Order read as first paper, the Leave was sanctioned under Rule 88 Part I, KSRs. As per representation read as second paper she had submitted a representation requesting to count the leave period for increment and this was rejected vide Government letter read as third fourth papers.

Smt. V. Girija has filed WP(C) 10291/2011 contending that she is eligible for LWA for study purpose under Rule 91 Part I KSRs instead of LWA already sanctioned under Rule 88 Part I KSRs.

Government have re-examined the matter. Since Smt. Girija availed LWA for B.Ed. Course under Rule 88 Part I, KSRs prior to the omission of third proviso to Rule 33(b)(2) from Part I, KSRs, she is eligible for the benefit under this Rule. In the circumstances, Government are pleased to extend the benefit of third proviso to Rule 33(b)(2) Part I, KSRs to Smt. V. Girija, Sewing

Teacher, Government High School, Ezhoor, Malappuram. The Director of Public Instruction and the Deputy Director of Education, Malappuram shall take further immediate necessary action in this regard. Necessary entries to the effect shall be made in the Service Book of the incumbent.
