ORDER

As per proviso to Rule 28 (A) (1) (I) (g) of GPF (K) Rules, on the date of application basic pay limit for availing Non- refundable withdrawal from GPF for the purchase of Motor car and Motor cycle / Scooter shall not be less than Rs. 10,500/- and Rs. 4600/- respectively. Consequent on the General Pay Revision with effect from 01-07-2004 ordered in the Government Order read as 2nd paper above, it is necessitated to make corresponding revision of existing basic pay limit under GPF(K) Rules. The Accountant General (A&E), Kerala, Thiruvananthapuram as per the letter read above has now informed that since the basic pay limit has not yet been revised in line with Government Order read above, sanction for withdrawals cannot be acted upon and hence requested to revise the existing basic pay limit at the earliest.

Government have examined the matter in detail and are pleased to revise the existing basic pay limit of Rs. 10,500/- and Rs. 4600 /- as Rs. 20,700/- and Rs. 7990/-

respectively, for availing non- refundable withdrawals from GPF, for the purchase of Motor Car and Motor cycle/ Scooter respectively.


