Sub: - House Building Advance Scheme to State Government Employees
Application invited for 2010-2011 – Additional Instructions issued

Ref: - G.O. (P) No.505/2009/Fin. dated 12.11.2009

In the Government Order dated 12.11.2009, Government have reintroduced the House Building Advance Scheme to State Government Employees and Teachers. A time frame for receipt of HBA application and processing the same before online registration was stated in para 6 of the Government Order cited. All the Heads of Departments and Sanctioning authorities are instructed to follow the above time frame for receipt of applications 2010-11. The following additional instructions are issued for information before online registration of application.

- 1) All the relevant portion of the HBA application form should be filled in by the applicant.
- 2) The address of the applicant/applicants both residential and office is mandatory in all cases of HBA application. The telephone number of the applicant/applicants should be entered in the application.
- 3) The treasury from which advance is to be encashed should clearly be stated in the application. In the case of Joint application, treasury of the main applicant need be highlighted.
- 4) The Joint application should be forwarded from the Head of Department of the elder joint party or else the benefit of age seniority will be lost.
- 5) The maximum eligible amount of advance should be limited in such a way that the repayment of each monthly instalment shall not exceed 80% of his/her basic pay.
- 6) The maximum instalment period of principal shall not exceed 144 months and that of interest shall not exceed 72 months. Interest will be recovered in such a way that each such instalment being not appreciably greater or less than the instalments by which the principal was recovered as stated in para (xiii) Article 244 C of KFC Volume 1.
- 7) The Joint application must be examined and signed by Head of Department of the co-applicant and forward to the Head of Department of the main applicant, where online entry is to be made, for countersignature. The signature of subordinate office head is not considered and such application will summarily be rejected.

8) Only original Certificates, Deed etc. in the order mentioned in Appendix II of the Government Order cited should be furnished with the application. The Heads of Departments and Sanctioning authorities should ensure the above before making online registration.
